Mayor McDevitt announced the approval of the minutes as submitted.

2. Mayor McDevitt read a proclamation proclaiming August 26, 1985 as

"Women's Equality Day".

Mayor McDevitt presented the proclamation to Sandra T. Wisniewski, Regional Coordinator for the Council on the Status of Women, Mrs. James, Mrs. Ruth Brandon, Julie Cogburn, and Florence Ryan.

Sandra Wisniewski invited all members of Council to the "Women's Equality Day" celebration on Monday, August 26, 1985 from 12:00 noon until 1:00 p.m. on the City/County Plaza.

#### PUBLIC HEARING - EXTENDING MORATORIUM - HAW CREEK AREA

#### ORDINANCE No. 1530 - AN ORDINANCE AMENDING ORDINANCE NO. 1519 EXTENDING THE

## MORATORIUM LIMITING DEVELOPMENT IN THE HAW CREEK AREA

3. A public hearing was held relative to extending the present moratorium in the Haw Creek area.

Mayor McDevitt opened the public hearing at 4:12 p.m.

The City Clerk presented the notice to the public, setting the time and date for the public hearing and the affidavit of publication.

Verl Emrick, Director of Planning, said the Planning and Zoning Commission

has been studying the problem of overtaxed sewer lines, streets and other parts of the infrastructure in the Haw Creek community in an effort to recommend a plan for future development in the area. He said the Alternatives for Asheville Committee is examining the potential for additional development and will make a recommendation as part of a comprehensive plan for the City. He said, in that regard, the Planning

and Zoning Commission had recommended that the current moratorium be extended until

a state moratorium on additional sewer hookups in a portion of the Haw Creek area expires on Janury 1, 1986. He said

the Planning and Zoning Commission would be having a work session with the Haw Creek Homeowners Association on August 21, 1985 relative to long-range planning for the Haw Creek area.

Roy Smucker, 6 Oak Drive, spoke in support of extending the moratorium in the Haw Creek area. He said the original reasons for imposing the moratorium are still valid.

Ed Dyson, with the Haw Creek Homeowners Association, said the members of the Association have worked to correct many problems in the Haw Creek area relative

to traffic, sewer, roads, etc. He said their main interest is in future develop-

ments and protection of the neighborhood. He said the majority of the residents in Haw Creek feel that the current zoning ordinance is too restrictive or too vulnerable for their area. He said after working with the Planning and Zoning Commission, the Homeowner's Association has presented a plan for a R-2A Zoning Classification. He said the Association has checked with the State and other cities relative to a new zoning designation. He said the State has assured them that there would be no problems in a new zoning district and this would not create spot zoning. He said the City of Asheville needs to develop a means of protecting neighborhoods. He said the Alternatives for Asheville Committee would be presenting a plan, but there was no assurance that the plan will be acted upon. He said the residents of Haw Creek are in favor of an extension of the present moratorium for sixty to ninety days, but felt that Council should act on establishing an additional zoning district for Haw Creek. He said the residents would be opposed to extending the moratorium until January 1, 1986 since there would be a new City Council elected in November and those members would have to be re-educated about the problems in Haw Creek.

Upon inquiry of Mayor McDevitt, Corporation Counsel Slawter said members of Council could consider zoning amendments during the time the moratorium is in effect.

Councilman Bissette also noted that Council could rescind the moratorium at any time if problems were worked out prior to January 1, 1986.

Councilman Price requested that the Planning staff give members of Council an official status report on Haw Creek improvements in sixty days, or by the middle of October, 1985.

Mayor McDevitt closed the public hearing at 4:33 p.m.

Mayor McDevitt said members of Council were furnished copies of the ordinance and it would not be read in its entirety.

Councilman Bissette moved for the adoption of Ordinance No. 1530. This motion was seconded by Councilman Price and carried unanimously.

On a roll call vote of 6-0, Ordinance No. 1530 passed on first reading.

Councilman Frank moved to suspend the rules and proceed to the second reading of Ordinance No. 1530. This motion was seconded by Councilman Price and carried unanimously.

Carr, Jr. that Ward 7, Sheet 55, Lot 7 be rezoned from R-5 Residential District to CS Commercial Service District. The property is located on Sweeten Creek Road at Old West Chapel Road. After review and discussion, the Commission voted to recommend to City Council that Ward 7, Sheet 55, Lot 7 be rezoned from R-5 Residential District to CS Commercial Service District. This ordinance was read on first reading on August 13, 1985.

# ORDINANCE NO. 1529 - AN ORDINANCE AMENDING ORDINANCE NO. 322, KNOWN AS "AN ORDINANCE PROVIDING FOR THE ZONING OF THE CITY OF ASHEVILLE," PROPERTY LOCATED AT 105 BUCHANAN ROAD (DR. E.B. CROSBY PETITION)

5. Consideration was given to the second reading of Ordinance No. 1529, an ordinance amending Ordinance No. 322 known as "An ordinance providing for the zoning of the City of Asheville," as amended - property located at 105 Buchanan Road

(Dr. E. B. Crosby peitition).

Mayor McDevitt said the Asheville Planning and Zoning Commission at a meeting held July 10, 1985, considered the petition of Dr. E. B. Crosby, Asheville Hand Center, that Ward 1, Sheet 8, Lot 70, be rezoned from R-3 Residential District to OI Office Institutional District. The property is located at 105 Buchanan Road. After review and discussion, the Commission voted to recommend to City Council that Ward 1, Sheet 8, Lot 70, be rezoned from R-3 Residential District to OI Office Institutional District. This ordinance was read on first reading on August 13, 1985.

Mayor McDevitt said this ordinance was previously read on first reading and would not be reread in its entirety unless there was specific request to do so.

On a roll call vote of 6-0, Ordinance No. 1529 passed on second reading.

# ORDINANCE NO. 1531 - AN ORDINANCE AMENDING SECTION 28-81.3, 28-82 AND 28-82.1 OF ARTICLE IV, SPEED REGULATIONS, OF CHAPTER 28 OF THE CODE OF ORDINANCES FOR THE CITY OF ASHEVILLE (SPEED LIMIT ON SOUTH FRENCH BROAD)

6. Consideration was given to an ordinance amending Section 28-81.3, 28-82 and 28-82.1 of Article IV, speed regulations, of Chapter 28 of the Code of Ordinances of the City of Asheville.

Mayor McDevitt said a petition has been submitted by the Aston Towers Tenants Association to set the speed on South French Broad Avenue, between Hilliard Avenue and Choctaw Street at 25 m.p.h. This petition is supported by the YWCA and Asheville Junior High School, and has also been endorsed by a resolution from the Asheville Housing Authority. The Traffic Engineering Division also recommends that the speed limit on South French Broad, between Timothy Street and Phifer Street, be set at 20 m.p.h. during designated school hours.

Mayor McDevitt said members of Council were furnished copies of the ordinance and it would not be read in its

entirety.

Councilman Frank moved for the adoption of Ordinance No. 1531. This motion was seconded by Councilman Price.

On a roll call vote of 6-0, Ordinance No. 1531 passed on first reading.

Mayor McDevitt said Riceville Road (SR 2002) had an established speed limit of 45 m.p.h. upon annexation by the City. This action will establish a Municipal Ordinance declaring the 45 m.p.h. speed limit and request a concurring ordinance by the Department of Transportation for this portion of Riceville Road.

Mayor McDevitt said members of Council were furnished copies of the ordinance and it would not be read in its entirety.

Councilman Bissette moved for the adoption of Ordinance No. 1532. This motion was seconded by Councilman Price.

# ORDINANCE NO. 1533 - BUDGET ORDINANCE AMENDMENT TO SHIFT FUNDING FOR A STAFF POSITION AT THE CHAMBER OF COMMERCE FROM THE GENERAL FUND TO CBDG

Mayor McDevitt said this appropriation will be used to fund one staff position at the Chamber of Commerce. Total funds shifted will be \$19,616.
