The invocation was given by Councilman Boland.

I. PROCLAMATIONS:

A. Resolution No. 87-144 - Resolution of appreciation to

the Planning Staff for their efforts in preparing the 2010 Asheville City Plan.

Mayor Bissette read the resolution.

Upon motion of Councilman Boland, seconded by

Councilman Michalove, Resolution 87-144 was unanimously adopted.

Mayor Bissette read the resolution.

Upon motion of Vice-Mayor Frank, seconded by Councilman Bratton, Resolution No. 87-145 was unanimously adopted.

II. PUBLIC HEARINGS:

A. Public hearing relative to site plan of the proposed

expansion of St. Marks Lutheran Church at 10 North Liberty Street.

Mayor Bissette said the Asheville Planning and Zoning

Commission at a meeting held April 8, 1987, reviewed a site plan of the proposed expansion of St. Marks Lutheran Church at 10 North Liberty Street. The site plan was prepared by Wood and Cort, Architects, and submitted in accordance with the Group Development Section of the Asheville Zoning Ordinance. After review and discussion, the Commission voted to approve the project subject to the following conditions: 1. That a variance be granted to permit a side setback of 6" instead of the required 8'; 2) That a variance be granted to permit 45 parking spaces instead of the required 56; 3) That a variance be granted to reduce the buffering on the north property line; and 4) Compliance with the Erosion Control Ordinance.

Mayor Bissette opened the public hearing at 4:20 P.M.

The City Clerk presented the notice to the public

setting the time and date for the public hearing and the affidavit of publication.

Verl Emrick, Director of Planning, said John Cort,

project architect, has requested that the public hearing be continued for one (1) week.

Councilman Tisdale said it was his understanding the developer is presently negotiating an agreement with the adjoining property owner relative to the proposed project being within 6" of the adjoining property. He requested that this agreement be completed before Council considers the plan.

Councilman Boland moved to continue the public hearing relative to the proposed expansion of St. Marks Lutheran Church at 10 North Liberty Street until August 25, 1987 without further advertisement. This motion was seconded by Councilman Price and carried unanimously.

III. OLD BUSINESS:

A. Ordinance No. 1643 - Third reading of Ordinance No.

1643, an ordinance amending Ordinance No. 322, being the Zoning Ordinance for the City of Asheville, as amended rezoning property in the area north of Hilliard, west of Clingman and southeast of West Haywood Street to Commercial Service District.

Mayor Bissette said the Asheville Planning and Zoning

Commission at a meeting held June 3, 1987, considered the rezoning petition, plus lots in an area North of Hilliard, West of Clingman and Southeast of West Haywood Street for possible inclusion in the Commercial Service District. The Commission voted to recommend to City Council that Ward 4, Sheet 3, Lots 22, 26, 27, 28, 29, 31, 32-1/4, 34, 36, 36-1/4, 37, 38, 237, 240, 241, and 252 be rezoned from R-3 Residential District to CS Commercial Service District.

On a roll call vote of 7-0, Ordinance No. 1643 passed on

third and final reading.

B. Ordinance No. 1644 - Third reading of Ordinance No.

1644, an ordinance amending Ordinance No. 322, being the Zoning Ordinance for the City of Asheville, as amended rezoning property located at Haywood Road and Nevada Avenue from R-3 Residential District to CS Commercial Service District.

Due to a conflict of interest, Mayor Bissette was

previously excused from vote and participation in this rezoning matter. He turned the meeting over to Vice-Mayor Frank.

Vice-Mayor Frank the Asheville Planning and Zoning

Commission at a meeting held May 13, 1987, reviewed and recommended that a portion of Lot 2-1/4, Sheet 11, Ward 5, be rezoned from R-3 Residential District to CS Commercial Service District.

third and final reading.

D. Ordinance No. 1646 - Second reading of Ordinance No.

1646, Ordinance to extend the corporate limits of the City of Asheville to an area lying to the west of Hendersonville Road under the authority granted by Part 3, Article 4A, Chapter 160A of the General Statutes of North Carolina.

Mayor Bissette said all legal requirements have been met

in order for Council to consider an ordinance to extend the corporate limits to an area lying to the west of Hendersonville Road.

Ralph Bishop spoke in opposition to the annexation ordinances.

On a roll call vote of 7-0, Ordinance No. 1646 passed on

second reading.

E. Ordinance No. 1647 - Second reading of Ordinance No.

1647, Ordinance to extend the corporate limits of the City of Asheville to a portion of the area generally known as the Oteen Area under the authority granted by Part 3, Article 4A, Chapter 160A of the General Statutes of North Carolina.

Mayor Bissette said all legal requirements have been met

in order for Council to consider an ordinance to extend the corporate limits to an area generally known as the Oteen Area.

On a roll call vote of 7-0, Ordinance No. 1647 passed on

second reading.

F. Ordinance No. 1648 - Second reading of Ordinance No.

1648, Ordinance to extend the corporate limits of the City of Asheville to a portion of the area generally known as the Haw Creek Area under the authority granted by Part 3, Article 4A, Chapter 160A of the General Statutes of North Carolina.

Mayor Bissette said all legal requirements have been met

in order for Council to consider an ordinance to extend the corporate limits to an area generally known as the Haw Creek Area.

On a roll call vote of 7-0, Ordinance No. 1648 passed on

second reading.

G. Resolution No. 87-146 - Resolution amending the report

of plans for extension of City services into the area to the west of the existing Corporate Limits proposed for annexation.

Mayor Bissette said the amendment will reflect the

reduction of the area proposed to be annexed to exclude a large area belonging to BASF, the Enka Village, and the Southeastern Container Company. The revised plan will reflect these changes.

Verl Emrick, Director of Planning, said the area

excluded for consideration of annexation included vacant land, which would not affect the qualifications of the area for annexation since the N.C. General Statutes specify that areas included in annexations must be developed.

Upon motion of Vice-Mayor Frank, seconded by Councilman

Price, Resolution No. 87-146 was unanimously adopted.

Mayor Bissette, in response to concerns expressed

relative to the annexation, handed out a cost sample outlining current expenses to property owners in the west area vs. anticipated expenses after annexation. He noted that property owners in the area would no longer

be required to pay a fire district tax, sanitary tax, the City would be picking up the cost for street lighting, individual fire insurance ratings would be less, and they should receive a savings on their state and federal income tax.

Councilman Michalove said he felt annexation is necessary for the City of Asheville to grow. He noted that the majority of services used by County residents, either directly or indirectly, are located in the City Limits of Asheville. He said it is the City of Asheville's responsibility to support many of these non-profit agencies even though County residents use these

services.

Vice-Mayor Frank moved for the adoption of Ordinance No. 1649. This motion was seconded by Councilman Boland.

On a roll call vote of 7-0, Ordinance No. 1649 passed on first reading.

Councilman Michalove moved to suspend the rules and proceed to the second reading of Ordinance No. 1649. This motion was seconded by Councilman Bratton and carried unanimously.

On a roll call vote of 7-0, Ordinance No. 1649 passed on second reading.

IV. NEW BUSINESS:

A. Ordinance No. 1650 - Ordinance establishing the City of

Asheville Police Officers' Disability Review Board for former members of the Asheville Policemen's Pension and Disability Fund.

Mayor Bissette noted that the Review Board will replace

the <u>old</u> Pension and Disability Board. The Board will evaluate future requests for "floor" guaranteed to retirees who sustain a disability "in the line of duty". Membership shall consist of: 1) member of City Council; 2) member of the Police Department; 3) licensed medical doctor; 4) City Manager or his designee; and 5) a member at large chosen by the City

Council.

Ralph Bishop requested a copy of the ordinance.

Councilman Michalove moved for the adoption of

Ordinance No. 1650. This motion was seconded by

Councilman Bratton.

On a roll call vote of 7-0, Ordinance No. 1650 passed

on first reading.

Councilman Michalove moved to suspend the rules and proceed to the second reading of Ordinance No. 1650. This motion was seconded by Councilman Boland and carried unanimously.

On a roll call vote of 7-0, Ordinance No. 1650 passed on second reading.

Councilman Michalove moved to suspend the rules and proceed to the third and final reading of Ordinance No. 1650. This motion was seconded by Councilman Boland and carried unanimously.

Urban Development allowing \$750 for each case.
