® B. Resolution No. 88 - 15 - Resolution guaranteeing a floor

of benefits to former members of the Asheville Firemen's Pension and Disability Fund

Mayor Bissette said City Council adopted Resolution No.

86-218 which guaranteed a floor of benefits to former members of the Asheville Policemen's Pension and Disability Fund. Former members of the Asheville Firemen's Pension and Disability Fund became members of LGERS as of January 1, 1979, but were not guaranteed a similiar floor of benefits. This resolution will provide the same guarantee to former members of the Asheville Firemen's Pension and Disability Fund as provided to former members of the Asheville Policemen's Pension and Disability Fund.

Dave Anders, with the Asheville Fire Department, said

the firefighters who have retired since 1979, who qualify for in-line-of-duty disability retirement benefits should be included in this provision and should be paid retroactive to the date they retired. He said the firefighters voted to go under the Local Government Employees' Retirement System with the understanding that they would not lose any of their past benefits they would have received as members of the former Asheville Firemen's Pension and Disability Fund.

Charles Penny, Assistant City Manager, said if Council

chose to do this it would cost approximately \$160,000.

After discussion, Mayor Bissette said members of Council

had looked at all aspects of these provisions and are concerned with the costs involved, particularly retroactive benefits.

Members of Council requested that the staff look into

Dave Anders request and furnish Council with additional information such as the type of disability retirement received by retirees since 1979 along with administrative alternatives.

Upon motion of Councilman Frank, seconded by Councilman

Price, Resolution No. 88-15 was unanimously adopted.

® C. Resolution No. 88 -16 - Resolution authorizing the

Mayor to execute a Municipal Agreement with the N. C. Department of Transportation for improvements to

McDowell Street (US 25).

Mayor Bissette said in the current projects included

in the Street & Sidewalk Bond program, new curb and sidewalk is scheduled for McDowell Street. McDowell Street is a State System street and the Municipal Agreement will allow the City to place new curb in areas where there is currently no sidewalk, and the North Carolina Department of Transportation will reimburse the City up to \$20,000 for the cost of placing the curb. Engineering estimates place the cost of replacing the curb at \$18,000; therefore, the \$20,000 maximum should totally cover the cost of

replacing the curb.
