engineering consultant to provide consultant services for sewer improvements in annexation areas West, South, and Haw Creek and Oteen. Thirteen engineering firms responded and submitted a proposal to our invitation. As stated in the solicitation, the proposal was to have (1) letter of interest, (2) project understanding statement, (3) schedule, (4) project personnel, (5) experience. The following is the rating of the three finalists. 1. Black and Veatch; 2. CH2M Hill; 3. Jordon, Jones & Goulding. The three finalists were interviewed and a contract was negotiated per the adopted policy, with the firm receiving the highest ranking, Black and Veatch.
