Mayor Bissette announced the approval of the minutes of the November 15, 1988 meeting as submitted.

# EMPLOYEES OF WATER AND SEWER DEPARTMENT - 1988 STATE CHAMPIONS IN TAPPING

The City Manager recognized employees of the Water and Sewer Department for becoming the 1988 State Champions in Tapping for the second year. He said the team beat the state and national record with a time of 1 minute 54.32 seconds. He said the team will be competing in the Nationals in Los Angeles in June, 1989.

#### PARKING VALIDATION STICKERS FOR LIBRARY PATRONS

The City Manager said due to a number of calls relative to repealing free parking in the Civic Center Parking Garage for residents of the City using the library facilities an interim solution has been decided upon. He said the City will issue to the Library validation stickers similar to the ones used by downtown merchants. He said the Library would have control of the parking stickers and this program would be monitored for several months to determine the usage of the Library and the cost involved and a determination can be made by Council whether to continue the program.

# A. Resolution to close a portion of Cliff Street in the

SUMMARY: A petition has been filed by Westgate

Shopping Center of Asheville, Inc. requesting that a portion of Cliff Street which has never been paved or otherwise utilized be permanently closed to the public use. This closing is in connection with the Westgate Shopping Center Expansion Project - Phase II. A public hearing was

held on September 27, 1988.

Mayor Bissette announced that this matter would be

postponed until December 20, 1988 meeting.

#### B. Third reading of Ordinance No. 1731 - amending Section

#### 19A-1 and 19A-11 of the Code of Ordinances (Grievance

#### Procedure) of the City of Asheville.

#### SUMMARY: Section 19A-1 is being amended to clarify

procedures for hearing group grievances because meeting with large groups can make it almost impossible to meet time deadlines of the present ordinance. This amendment would allow a department head

the flexibility to meet with a group of employees if he/she so desires; however, it would clarify that it is not a requirement of the grievance procedure. Section 19A-11 will clarify who the department head must <u>confer</u> with prior to rendering a decision on a grievance as opposed to who must actually attend the grievance conference. Section 19A-11 also eliminates the time allotted for the City Manager to render his decision provided the conference is held within 10 days after the appeal is received by the City

Clerk.

Mayor Bissette announced that this matter would be

postponed until December 20, 1988 meeting.

#### C. Ordinance No. 1737 - Third reading of an ordinance

#### amending Chapter 25 (Streets and Sidewalks) of the Code

#### of Ordinance of the City of Asheville (Parade Permits)

Mayor Bissette said this ordinance will amend

Section 25-16 (C) (1-5) by deleting same and inserting new language. The new language would require that a written application for a permit is to be filed not less than 72 hours in advance of such parade. It would also require that the applicant for a permit pay an administrative filing fee, to be set by the Council and included in the

City's Fees and Charges Manual.

Mayor Bissette said this ordinance was previously

read on first and second reading and would not be reread in its entirety.

impression that there is a procedure to follow to move ahead quickly on dwellings that are a threat to life, safety, and health without waiting on the process of adopting an ordinance.

### COMMENTS RELATIVE TO COUNCIL'S SELECTION OF NEW COUNCILMEMBER

W. Steve Wilborn, President of the Asheville Branch of the NAACP, read the following prepared statement:

November 28, 1988

The Asheville Branch of the NAACP would like to go on record to express our objection to the process that City Council used to appoint Mr. Robert York to fill the unexpired term of former council member Walt Boland. While it is understood that Council executed its duty in filling the vacancy, the nomination and appointment process was, in our opinion, done secretly and in a style reminiscent of back-room politics. Interested Asheville citizens should have been given an opportunity to comment, ask questions, and express their opinions about, 1) the process that would be used to nominate and appoint Mr. Boland's replacement, 2) the qualifications members of Council would be looking for in prospective candidates, in addition to the requirement that (s)he be a Democrat and, 3) when interviews would be held. As a result of your failure to fully disclose all the procedures surrounding this situation, there is and continues to be a great deal of discussion in the Greater Asheville community concerning the expeditious manner in which the appointment was made.

Those actions and inactions, coupled with your pro-business at the expense of neighborhood/city-wide problems have diminished our trust in your good-faith effort to represent all the people equally. Therefore, at this time, we formally request that you

agree to voluntarily establish a district representative form of government for City Council. We also request that you give us an answer within six weeks from this date. Thank you.

A more public process will benefit the entire community by helping us to recognize each other's strengths and needs, and teaching us to work together constructively.

# **COMMENTS BY BOB BROWN - ELECTION OF SCHOOL BOARD MEMBERS**

Bob Brown, Chairman for the Citizens for a Vote in the Schools, read the following prepared statement:

Thank you for the opportunity to present this petition to you. It contains the signatures of eight hundred and fifty-six persons who request that the Council take the necessary steps to provide Asheville with an elected Board of Education.

This issue is not raised as a response to the performance of current or past Boards, but in the belief that the nature and importance of public education requires an elected Board.

An appointed Board by its character does not require or seek public involvement or approval. We find the Board, appointed in executive session, conducting the majority of its business in executive session. This kind of secrecy is more appropriate to foreign intrigue than to the education of children.

This Board should be elected by the public because the operation of the public schools is public business. It involves millions of tax dollars and our children's future.

Open government is good government. Thousands of men and women in Asheville join us in asking City Council for an elected Board of Education. We are not asking for unusual privileges. Of one hundred and forty school districts in North Carolina, only eleven fail to give the people a vote on their Board of Education. The people of Asheville can surely choose a Board wisely, and join residents of the great majority of school districts in North Carolina and the nation who see these elections as a simple instance of their rights as citizens.

Please consider this request. In the event that Council will not grant it, we ask that the Council members voice their objections publicly.
