## **®ANNOUNCEMENT - ASHEVILLE TROLLEY CARS RETURNING**

Karen Fields, Executive Director of Asheville-Buncombe Discovery, said several months ago she presented a proposal to Council for the acquisition of two (2) old Asheville Trolleys which were in Spindale.

She said an Asheville Trolley Committee was formed to raise funds for the acquisition and restoration of the Asheville Trolleys. She said a deadline of January 24, 1989 was set to raise \$15,000 to buy the cars and \$10,000 to transport them up the mountain. She said two weeks ago, the Asheville Trolley Committee began a final, intensive effort to find the money. She said on Monday, January 23, they were far short from their goal. However, Edna and Wayne Blanton from Blanton's Business College decided that the trolleys deserved to be brought home and took the necessary action to ensure their return by donating \$15,000 for the Asheville Trolleys and offered to take care of the transportation. She said with the support of the Blantons in helping transport the cars and with the additional support of interested groups across the state, they now have a total of \$19,276 in a special trolley account with Asheville-Buncombe Discovery.

She said the cars should be ready for the journey to Asheville within two months and the committee will begin meeting immediately to determine a site for the cars during restoration and to begin work for a feasibility study on the best use of these trolleys for the people in Asheville.

Mayor Bissette introduced the members of the Asheville Trolley Committee in attendance and expressed the City's appreciation for their efforts, with particular appreciation to Edna and Wayne Blanton, who have made trolleys in Asheville a reality again.

#### ® A. Ordinance No. 1748 - Budget Ordinance amendment to

# provide funding for career development program in Police Department

The City Manager said a Career Development Plan was

adopted by the Civil Service Board and put into effect in January of 1983 setting up four classes of Police Officers -Police Officer Trainee, Police Officer I, Police Officer II, and Police Officer III. He said in July of 1985, the City implemented a new pay plan City-wide and at that time the Police Office II and Police Officer III positions were combined into one class title - Police Officer Senior. He said the requirement for movement from Police Officer to Police Officer Senior was three continuous years and an accumulation of 25 education and training points. He said somewhere along the line this action was not taken and 27 officers are eligible for upgrading to Police Officer Senior. He said 12 of the officers have not yet met their training requirements (points); however it would be his recommendation that the 27 officers be upgraded and back pay benefits awarded from the time they became eligible and that the 12 that have not met their requirements also be given the back pay benefits and be given a period of two years to obtain the necessary training. He said the cost associated with this action would be \$61,514.61. He said adoption of this budget amendment would allow this to take place.

Councilman York moved for the adoption of Ordinance No.

1748. This motion was seconded by Vice-Mayor Michalove.

On a roll call vote of 7-0, Ordinance No. 1748 passed

on first and final reading.

# **®REPORT - WIND IN THE OAKS UPDATE**

The City Manager said, as of today, the City has been

in contact with all but one property owner in the Wind- in-the-Oaks complex. He said either inspections and/or return visits for explanation and clarification have been scheduled. He said no more major structural violations have been found. He said the City met with the Board of Directors at the Wind-in-the-Oaks and they have indicated a willingness to help get responses from all Wind-in-the-Oaks occupants.

The City Manager said a new procedure has been

implemented for conducting final inspections for structural, electrical and plumbing code compliance at the same time, with a limited option for temporary CO's (for which a permit-holder must apply in writing) in cases where utilities are needed before a permanent CO can be authorized.

The City Manager took exception to a recent editorial

in the newspaper regarding the issuance of Certificates of Occupancy. He said he realizes that editorials are only opinions but the information in the editorial was not factual. He stressed that a Certificate of Occupancy is not required prior to the sale of a structure but prior to occupancy.
