APPROVAL OF MINUTES - JANUARY 24, 1989

Mayor Bissette announced the approval of the minutes of

the January 24, 1989 meeting as submitted.

®I. PROCLAMATIONS:

®Resolution No. 89-7 - Resolution in memory of William F. Algary

Mayor Bissette read a resolution in memory of William F. Algary, a former member of the Council of the City of Asheville from September, 1955 until May, 1969.

Upon motion of Councilman Price, seconded by Councilman Frank, Resolution No. 89-7 was unanimously adopted.

® A. "Heart of Asheville Month" - February, 1989

Mayor Bissette read a proclamation proclaiming

February, 1989 as "Heart of Asheville Month" which is to celebrate the revitalization of downtown with fellow Ashevillians.

Mayor Bissette presented a copy of the proclamation to

Mark Rosenstein, President of the Downtown Association, who explained the activities taking place during February, 1989 to celebrate the revitalization of

downtown.

® B. "American History Month" - February, 1989

Mayor Bissette read a proclamation proclaiming

February, 1989 as "American History Month". He presented a copy to Clare McDowell with the

Daughters of the American Revolution.

®II. PUBLIC HEARINGS:

®III. OLD BUSINESS:

® A. Resolution to close a portion of Cliff Street in the

City of Asheville, North Carolina.

Mayor Bissette said a petition has been filed by

Westgate Shopping Center of Asheville, Inc. requesting that a portion of Cliff Street which has never been paved or otherwise utilized be permanently closed to the public use. This closing is in connection with the Westgate Shopping Center Expansion Project - Phase II. A public hearing was held on September 27, 1988. Action on the resolution has been continued on several occasions and until January 31, 1989.

The City Attorney said this resolution should be deleted

since the petitioners have withdrawn their petition to

close a portion of Cliff Street.

®IV. NEW BUSINESS:

® A. Report relative to Pritchard Park Bus Transfer Point.

Bob Carr, Chairman of the Asheville Downtown Commission,

said efforts are being made to redesign Pritchard Park to facilitate multiple events in the park and to allow for a variety of functions necessary for revitalization efforts downtown. He said Pritchard Park is the anchor for downtown retail business and is to be known as the "hot spot" or "happening spot" in downtown.

Mr. Carr said in order to proceed with the redesign a

study was conducted with the assistance of LDR, a consultant for downtown revitalization, to relocate the Pritchard Park Bus Transfer Point. He said meetings were held with the Asheville Transit Authority in a search for a better hub site for a bus transfer point close to downtown. He said after considering all factors involved a site on South Lexington Avenue was chosen as the best possible location. He said this site has advantages and disadvantages but the City already owns the property; it is located on a 2-way street and is 1-1/2 blocks from the present bus transfer point. He said the Downtown Commission and the Asheville Transit Authority would be considering the use of a motorized shuttle bus service to this location.

He said grant funds would more than likely be available

to help with this project; however, they need Council's approval of this idea in order to continue with this project. He said it would cost approximately \$8,000 but federal monies would be available next spring and the City could be reimbursed with grant funds through the Urban Mass Transportation Administration. He said in his opinion this is the next major step in encouraging reinvestment downtown.

Upon inquiry of Councilman Price, Carl Owenby with the

Asheville Transit Authority, said the Authority also had some concerns about receiving input from individuals that

presently use the bus system. He said the bus drivers have be interacting with the users and will be given "handouts" in order to receive comments about moving the bus transfer point.

Vice-Mayor Michalove said he would like to know what

additional operational costs would be involved with relocating the bus transfer point.

Councilman York said he would like to know the present

income the City receives from the existing parking lot on South Lexington Avenue.

Councilman Frank said some time ago she had requested

that a survey be taken of the ridership to determine how many of these individuals are shoppers in downtown. She said she felt there would be a reluctance from the residents of Battery Park and Vanderbilt Apartments in moving the bus transfer point.

Carl Owenby and Mayor Bissette said they felt the

implementation of the shuttle bus service would help.

John Daniel with the Downtown Commission, said in

essence they are asking the City to appropriate \$8,000 for this project. He said it would probably take two (2) years for implementation of the project.

After discussion, the City Manager was instructed to

proceed with the preparation of a budget amendment in the amount of \$8,000 for Council's consideration.

® B. Resolution authorizing the condemnation of property in

the Hazel Mill Bridge Replacement Project.

Mayor Bissette said this resolution will authorize

the Asheville Housing Authority to condemn, if necessary, the C. G. Johnson Heirs property on Hazel Mill Road for the Hazel Mill Road Bridge Replacement Project. Offers and negotiations for the acquisition of this property have not resulted in an agreeable settlement and condemnation appears

to be the only remaining method of acquisition.

After discussion, it was decided to postpone action

on this resolution in order for Council to receive additional information and to review the plans for the Hazel Mill Bridge Project.

Councilman Bratton also requested that the

individuals involved in the condemnation be notified that Council is considering taking such

action.

® C. Resolution authorizing the condemnation of property in

the Murdock Avenue Bridge Project.

Mayor Bissette said this resolution will authorize

the Asheville Housing Authority to condemn, if

necessary, the properties at 191 and 200 Murdock Avenue owned by the Congregation Beth Isreal and O'Donald for the Murdock Avenue Bridge Project. Offers and negotiations for the acquisition of this property have not resulted in an agreeable settlement and condemnation appears to be the only

remaining method of acquisition.

After discussion, it was decided to postpone action

on this resolution in order for Council to receive additional information and to review the plans for the Murdock Avenue Bridge Project.

Councilman Bratton also requested that the

individuals involved in the condemnation be notified that Council is considering taking such

action.

® D. Resolution authorizing the condemnation of property in

the Chestnut Street Bridge Replacement Project.

Mayor Bissette said this resolution will authorize

the Asheville Housing Authority to condemn, if necessary, the properties on Broadway owned by Robert C. & Betty Lawrence and Maxine M. Klutts for the Chestnut Street Bridge Replacement Project. Offers and negotiations for the acquisition of this property have not resulted in an agreeable settlement and condemnation appears to be the only

remaining method of acquisition.

After discussion, it was decided to postpone action

on this resolution in order for Council to receive additional information and to review the plans for the Chestnut Street Bridge Project.

®H. Scheduling public hearing relative to floodway

revisions to Smith Mill Creek for project of Charles S. Livengood at 46 New Leicester Highway for February 14,

1989.
