III. OLD BUSINESS:

A. Ordinance amending the Charter of the City of Asheville

to provide for nonpartisan elections with two or four year staggered terms.

Mayor Bissette said the North Carolina General Statute

sec. 160A-101 provides that any city may change various aspects regarding its form of government, including the manner in which municipal primaries and elections are conducted. Municipal elections in the City of Asheville are currently conducted on a partian basis and City Council members serve concurrent two year terms. A public hearing was held on this ordinance on April 4, 1989.

Mayor Bissette said members of Council discussed the

issue of nonpartisan elections during their pre-council work session and reached a consensus to schedule a referendum on the issue of nonpartisan municipal elections. He said the tentative schedule for this process is as follows:

Herbert Hyde, Chairman of the Buncombe County

Democratic Executive Committee, said in 1985 more than 100 members of the Buncombe County Democratic Party adopted a Statement of Principles, one of which stated that partisan political parties are necessary for good government. He said members of Council must have someone to answer to and the only way that can happen is through political government. He said nonpartisan elections would lower the esteem and accountability of government officials.

Shirley Birdie, President of the League of Women

Voters, said they did not wish to take a position on the issue of nonpartisan municipal elections; however, they are strongly in favor of a referendum on the issue and the establishment of an educational forum on partisan/nonpartisan elections.

John Fobes said he was in favor of a referendum on the

issue of nonpartisan elections and felt that more public discussion on the subject is needed.

Ralph Bishop said the City of Asheville needs honest

people on Council and in government.

Vice-Mayor Michalove moved to postpone action on the

issue of nonpartisan elections until June 27, 1989. This motion was seconded by Councilman York and carried

unanimously.

IV. NEW BUSINESS:

A. Resolution No. 89-51 - Resolution endorsing the

recommendations of the NC Highway Study Commission.

Mayor Bissette said this resolution was requested by the

US 23/I-26 Corridor Association. The resolution will be presented, as part of a total Western North Carolina effort, to the Governor, the Secretaries of Transportation and Commerce and key legislators on April 12, 1989 in Raleigh.

Upon inquiry of Councilman Price, Mr. Burroughs from the

Land-of-Sky Regional Council, outlined a portion of the recommendations of the NC Highway Study Commission. He said a complete list of the recommendations could be furnished to members of Council.

Councilman Frank commented that the proposed Highway

Bill will increase Powell Bill funds by one-third and funds will be made available for unpaved secondary roads.

®(1) KENNETH HAIR APARTMENTS OFF EDGEWOOD ROAD

Mrs. Albrice said the Asheville Planning and Zoning Commission on April 5, 1989, reviewed and approved the site plan of **Kenneth Hair Apartments off Edgewood Road** subject to the City sewer easement being shown on the site plan and compliance with the Erosion Control Ordinance. She said the project will consist of four two-story units. She said no public comments were

received during the meeting.

Council accepted the recommendation of the Planning and Zoning Commission relative to the Kenneth Hair Apartments off Edgewood Road.

®(2) COUNTRY TOWNES OF HAW CREEK, PHASE II - WATERS ROAD

Mrs. Albrice said the Asheville Planning and Zoning Commission on April 5, 1989, reviewed and approved the site plan of **Country Townes of Haw Creek, Phase II - Waters Road** subject to buffering of development to comply with 1985 site plan and ordinance as approved by the Planning Director and compliance with the Erosion Control Ordinance. She said the project will consist of twenty-two residential duplexes. She said no public

comments were received during the meeting.

Council accepted the recommendation of the Planning and Zoning Commission relative to the site plan for the **Country Townes of Haw Creek - Phase II on Waters Road.**

®(3) LaPIER DEVELOPMENT - - PEARSON BRIDGE ROAD

Mrs. Albrice said the Asheville Planning and Zoning Commission on April 5, 1989, reviewed and approved the site plan of **the LaPier Development on Pearson Bridge Road** subject to the site being reduced to .99 acres as shown on the plan; buffer planted across east, north and south property lines; legal access being maintained from Pearson Bridge Road to LaPier Court; parking lot tree requirement being satisfied; and compliance with the Erosion Control Ordinance. She said the project will consist of five residential duplexes. She said no public comments were received during the meeting.
