The invocation was given by Councilman Martin.

APPROVAL OF MINUTES - APRIL 25, 1989

Mayor Bissette announced the approval of the minutes of the April 25, 1989 meeting with minor corrections.

I. PROCLAMATIONS:

A. Proclamation - "Respect for Law Week" -

May 1 - 7, 1989

Mayor Bissette read the proclamation and presented a

copy to John Teeter with the Asheville Optimist Club. The Asheville Optimist Club annually sponsors "Respect for Law Week".

B. Presentation by Western North Carolina Development

Association.

Patricia O. Brinkley, President of the Western North

Carolina Development Association, Inc., read a resolution adopted by the Western North Carolina Development Association, Inc. Board of Directors expressing their sincerest appreciation to the City of Asheville for providing them office space for 40 years at a nominal fee. She said the City Hall Building Renovation necessitated that the Western North Carolina Development Association vacate the space it has occupied for 40 years.

II. PUBLIC HEARINGS:

A. Public hearing relative to final subdivision plat of

Trapper's Run (submitted as Haw Creek Subdivision).

Mayor Bissette said the Asheville Planning and

Zoning Commission on May 25, 1988, reviewed and approved the preliminary subdivision plat of Trapper's Run (submitted as Haw Creek Subdivision),

subject to the following contingencies:

1) Compliance with the County's Erosion Control

Ordinance;

- 2) Compliance with the County's Flood Plain Ordinance;
- 3) Variances by Board of Adjustment on front lot width for lots where required; and
- 4) 35' building setback line on Lots 1 and 34 along Haw Creek Road and 17-1/2' building setback

line on corner lots 16, 26, 27 and 7.

These contingencies have been complied with and the

final plat is submitted for your approval.

Mayor Bissette opened the public hearing at

4:30 p.m.

The City Clerk presented the notice to the public

setting the time and date for the public hearing and the affidavit of publication.

Tom Elmore, with the Planning Department, presented

the final plat stating that the developer has resolved all the contingencies outlined by the Planning and Zoning Commission. He said the plat received reviews from city departments and the Public Works Department is concerned about the infrastructure not being completed to city standards before being annexed and accepted by the City.

Ron Brondyke, Attorney representing the developer,

spoke in support of the final plat for Trapper's Run.

Mayor Bissette closed the public hearing at

4:34 p.m.

Procurement Plan states the Policy of the City with regard to providing equal opportunity for minority and women owned business enterprises (M/WBE) in all aspects of City contracting and purchasing programs. The plan also includes goals for M/WBE participation in overall City contracting and procurement and describes responsibilities of the City and contractors to enhance efforts to meet the goals.

Mayor Bissette said members of Council have been

requested to postpone action on this matter for two (2) weeks giving several groups an opportunity to review the proposed plan and to prepare their comments for Council.

Joe Webster, with the Asheville Chapter of the NAACP,

said he would make his comments on the plan when Council considers the issue in two weeks. He said he felt the goals in the plan are too low and expressed concern that the plan is for only 1988-89.

Marilyn, encouraged Council to adopt the plan.

She said a letter has been received from the National NAACP office relative to the proposed plan. She said this action may encourage women and blacks to bid on providing government services.

Ralph Bishop requested a copy of the proposed resolution

and plan. (The City Manager furnished Mr. Bishop with a copy of the resolution and plan).
