The City Attorney said proceedings have heretofore been

instituted in accordance with the City of Asheville Housing Ordinance No. 1370, Section 8-29(B)(2), as authorized by N.C. Gen. Stat. sec. 160A-443(2) and a condemnation hearing held on March 13, 1989. At said hearing, it was determined that the dwelling at 26 Mount Clare Avenue was unfit for human habitation. The owner(s) of this dwelling was given 10 days from receipt of the Order of Finding and Fact to either renovate or demolish the dwelling, and the owner(s) have not complied with said Order in any respect and no improvements are underway or being made upon the property.

The City Attorney highlighted the Order of Finding and

Fact and presented photographs of the dwelling. He said no response has been received from the property owners.

A discussion was held relative to the length of time it

takes to have a house demolished when it is unfit for human habitation.

be adopted would provide for a 94% tax collection rate. He said the budget also reflects revenue from the County of Buncombe for law enforcement reimbursement.

Jim Barrett, Vice-President of Home Share, a program of

ABCCM, requested that the City provide funding in the amount of \$3,000 for a three month period for the operation of Home Share.

Mayor Bissette suggested that Mr. Barrett talk with the

City Manager after the meeting regarding the request and to talk with the Land-of-Sky Regional Council since they also provide the same type of service.
