Mayor Bissette announced that Council would discuss the partisan/nonpartisan election and district representation issue on August 15, 1989.

## TASK FORCE ESTABLISHED - "PEOPLE FOR JUSTICE"

Mayor Bissette said at last week's Council meeting Council established a Task Force to formulate the concerns from the "People for Justice" Task Force. He said the make up of that committee would be Councilman York, Police Chief Gerald Beavers,

City Manager Doug Bean, Dwight Mullen, Chairman of the Asheville-Buncombe Community Relations Council and four representatives from the "People for Justice" Task Force to include Andrea Purcell, Marilyn Bass, Otis Ware, and Lydia James. He said the group would be working through the Asheville-Buncombe Community Relations Council.

A. Public hearing relative to rezoning property located at

614 Hendersonville Road for Mr. Robert Reeves.

Ordinance No. 1774 - An ordinance rezoning property

#### located at 614 Hendersonville Road for Mr. Robert Reeves

Mayor Bissette said the Asheville Planning and Zoning

Commission on July 5, 1989, reviewed and recommended approval of rezoning Ward 7, Sheet 5, Lot 17, from R-3 Residential District to CH Commercial Highway District.

Mayor Bissette opened the public hearing at 4:20 p.m.

The City Clerk presented the notice to the public

setting the time and date for the public hearing and the affidavit of publication.

Carol Alberice, from the Planning Department, presented

the rezoning request. She said the property is located on the corner of Hendersonville Road and Fairview Road and is currently used as a commercial automobile repair shop. She reviewed the surrounding zoning in the area and said the rezoning is in accordance with the comprehensive plan. She said two comments were received from area residents - one requesting that their property be rezoned and one opposed to the noise from the repair shop but not opposed to the rezoning.

Robert Reeves, petitioner, requested that the ordinance

be read on all three readings at today's meeting. He said he was faced with a time problem in dealing with the North Carolina Department of Transportation on a right-of-way problem.

Mayor Bissette closed the public hearing at 4:28 p.m.

Mayor Bissette said members of Council were previously

presented copies of the ordinance and it would not be read in its entirety.

Vice-Mayor Michalove moved for the adoption of Ordinance

No. 1774. This motion was seconded by Councilman Frank.

Department prior to soil disturbance; and

2. Planning Director approval of a revised site

plan depicting: a) a proposed buffer meeting the specifications of the buffer ordinance, and b) a

functional parking arrangement that meets the

standards of the ordinance.

Mayor Bissette opened the public hearing at

4:31 p.m.

The City Clerk presented the notice to the public

setting the time and date for the public hearing and the affidavit of publication.

Tom Elmore, with the Planning Department, said the

developer plans to construct a two-story four unit house at the corner of North and Forsyth Street. He said the property is zoned R-3 Residential. He said there is a buffer proposed on the north and south of the property. He said the Board of Adjustment approved a 20' setback for the front yard; lot area of 12,501; and lot width of 50'. He said all contingencies placed on the approval by the Planning and Zoning Commission have been resolved.

Mr. Elmore said a petition was presented to the

Planning and Zoning Commission by Norma Creighton, with thirty-three (33) signatures in general opposition. He said the petition stated such concerns as maintenance, setbacks, grading, and screening of garbage dumpsters.

A discussion was held relative to the screening of

garbage receptacles. It was determined that a dumpster was not required for the project that a maximum of six (6) garbage cans could be used.

Mayor Bissette closed the public hearing at

4:40 p.m.

Councilman York moved to approve the site plan for

the 4-unit apartment at North and Forsyth Streets as recommended by the Planning and Zoning Commission and further that appropriate screening be maintained around the garbage receptacles. This motion was seconded by Councilman Price and carried

unanimously.
