reviewed the rezoning request and the surrounding zoning. She said this rezoning meets the goals and objectives of the 2010 plan.

On a roll call vote of 7-0, Ordinance No. 1807

passed on second reading.

A. Award of bids for automobiles and trucks for the City of

Asheville.

The City Manager said this is the first purchase

contract that was made jointly with the Buncombe County Purchasing Department. He said he felt considerable savings

can be made with joint purchasing contracts. He said this action is for the award of 30 vehicles consisting of 12 police vehicles, 10 trucks (various sizes), 7 sedans and 1 van. He said the total award is in the amount of \$396,495.00.

Bid summary is on file in the Office of the City Clerk.

Councilman Frank moved for the award of bids for

automobiles and trucks for the City of Asheville as recommended by the Purchasing Department. This motion was seconded by Vice-Mayor Moore and carried unanimously.

C."

Tony Gilbert, with the U. S. Postal Service, said this will allow 80,000 to 85,000 pieces of mail to be cancelled daily and would be going all over the world. He said he felt this would be a very good promotion for the City of Asheville.

Mayor Michalove thanked the Board of Directors of Light Up Your Holidays and the U. S. Postal Service staff for helping to initiate this program.
