located on Old County Home Road - petition of Turnamics, Inc., Owner.

Mayor Michalove opened the public hearing at 4:16 p.m.

The City Clerk presented the notice to the public

setting the time and date for the public hearing and the affidavit of publication.

Carol Alberice, from the Planning Department, said the

Asheville Planning and Zoning Commission on October 3, 1990, reviewed and recommended approval of the rezoning. Subject property is 5.23 acre site with existing warehouse manufacturing facility on part of the acreage. The facility currently is a nonconforming grandfathered use in a commercial service zone. She reviewed the surrounding zoning and property use.

She said the Planning Staff recommended tabling the

rezoning request at this time. She said the staff was concerned that the zoning would not be appropriate for the area;

however, the staff was very supportive of this type of development in this area.

Pat Whalen, Attorney for petitioner, said Turnamics

wants to enlarge their plant which would produce more jobs for the Asheville area. He said Turnamics has been in this location for the past twenty years and is a non-polluting business. He said they contacted the residents and commercial businesses in the area and received no objections to the rezoning.
