APPROVAL OF MINUTES

Mayor Michalove announced the approval of the minutes

National Art Exhibit, said the High Country Arts Guild and the Eastern Bank of Cherokee are sponsoring the American Indian National Art Exhibit on September 25 - 29, 1991. She requested Council's support through the adoption of a resolution or a proclamation.

A. Public hearing relative to Memorial Mission Hospital -

East Parking Deck.

Mayor Michalove opened the public hearing at 4:12 p.m.

The City Clerk presented the notice to the public setting the time and date for the public hearing and

the affidavit of publication.

Don Sherrill, from the Planning Department, said the

Planning and Zoning Commission has recommended to the

Council that the site plan of the Memorial Mission Hospital East Parking Deck at the intersection of Biltmore Avenue and Doctors Drive be approved subject

to the following contingencies:

- 1. Compliance with conditions to assure adequate fire
- protection, as identified in memo from Mike

Jones dated October 12, 1990;

2. Approval by City Council of a variance to permit

the reduction in the front yard setback;

3. The parking deck be constructed in the exact

location shown on plan C2.2, revised on November

29, 1990 and giving the Planning Director the

authority to approve movement of the proposed

parking deck up to 2 feet closer to Biltmore

Ave.;

- 4. Receipt of water availability letter; and
- 5. DOT approval of driveway permit.

Mr. Sherrill said this would be a five-story parking deck

with 605 spaces. By the use of a map, he reviewed the surrounding zoning and use of the properties. He said the variance would allow construction of the deck to be

16.9' from the right-of-way line and giving the Planning Director the authority to approve movement of the parking deck up to 2 feet closer to Biltmore Avenue or 14.9' from

the right-of-way line.

Manager to sign an agreement providing for delivery of fire protection services to the Veteran's Administration Medical Center at Oteen through January

31, 1991.

The City Manager said the present contract expired

December 31, 1990. The Veterans Administration has had a fire protection contract with the City since 1975. They and the Fire Department staff are and have been renegotiating a contract. This will extend the contract through January 31, 1991 until a new contract can be negotiated.

specific request to do so.
