**ELECTION AND OATH OF OFFICE OF THE SEVENTH MEMBER OF THE ASHEVILLE CITY COUNCIL**

Councilman Newman nominated Bryan Freeborn to fill the unexpired City Council term left vacant by Mayor Bellamy, as Mr. Freeborn received the 4<sup>th</sup> highest votes from the November 8, 2005, General Election. Councilwoman Cape seconded the nomination.

After hearing no more nominations, Mayor Bellamy closed the floor for nominations.

Mayor Bellamy called for a vote, resulting in Bryan Freeborn being appointed to serve the unexpired term of Mayor Bellamy until December 4, 2007, on a 4-2 vote, with Councilman Davis and Councilman Mumpower voting "no."

City Clerk Magdalen Burleson administered the Oath of Office to Councilman Bryan Freeborn.

## **ELECTION OF VICE-MAYOR**

Councilwoman Cape nominated Councilwoman Jones as Vice-Mayor of the City of Asheville. Councilman Newman seconded the nomination.

After hearing no more nominations, Mayor Bellamy closed the floor for nominations.

Mayor Bellamy called for a vote, resulting in Councilwoman Jones being appointed as Vice-Mayor on a 5-1 vote, with Councilwoman Jones abstaining from voting and Councilman Mumpower voting "no."

## **COMMENTS FROM MAYOR**

Mayor Bellamy shared a few thoughts about the work off City Council over the next few years. She felt we needed to review our vision for Asheville's land use plan, development standards and annexation policies. Basic City services need to be a top priority for this Council. City Council must begin to look at ways we can be a player in helping create an environment where people live and work in the community, by (1) embracing the HUB project, the new regional economic development plan and see what part we can undertake to assist in developing a stronger and more inclusive economy; and (2) creating an affordable housing plan that gives clear direction for the inclusion of more housing for our low to moderate income individuals and families. She is committed to greater public involvement in developing the future of our water utility. In summary, she asked for the support of Council, the community, county officials, and state officials. It is her goal to actively partnership and have an active relationship with the community for the best of the entire community.
